Peace-Loving Muslims?

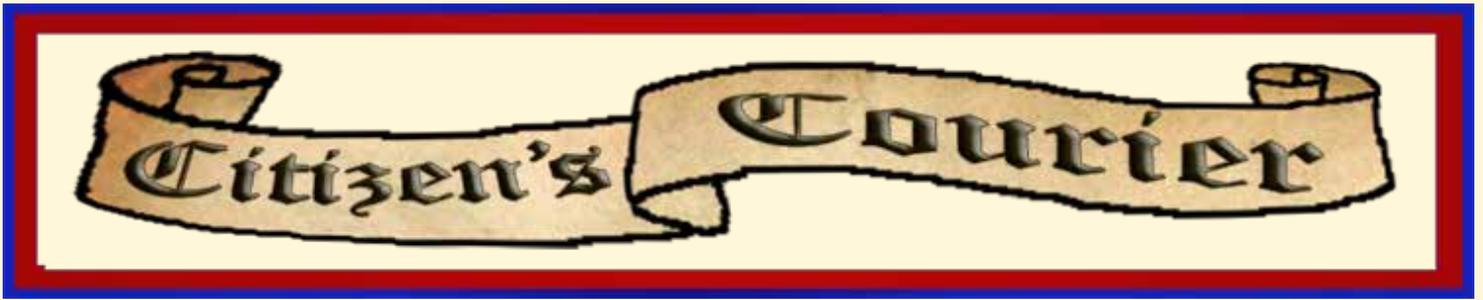

The Ammunition Ban

oppose attempts to prohibit ownership of guns by law-abiding citizens, and stand against all laws which would require the registration of guns or ammunition.


As this is being written, the Obama Administration and the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE) are proposing a ban on certain ammo with the exception of its use by the military and law enforcement agencies. This ban combined with other unconstitutional weapon bans creates yet another oppressive action by our government and clearly defines their actions as tyrannical based on the tenets of our founding fathers and framers of the US Constitution and Bill of Rights.

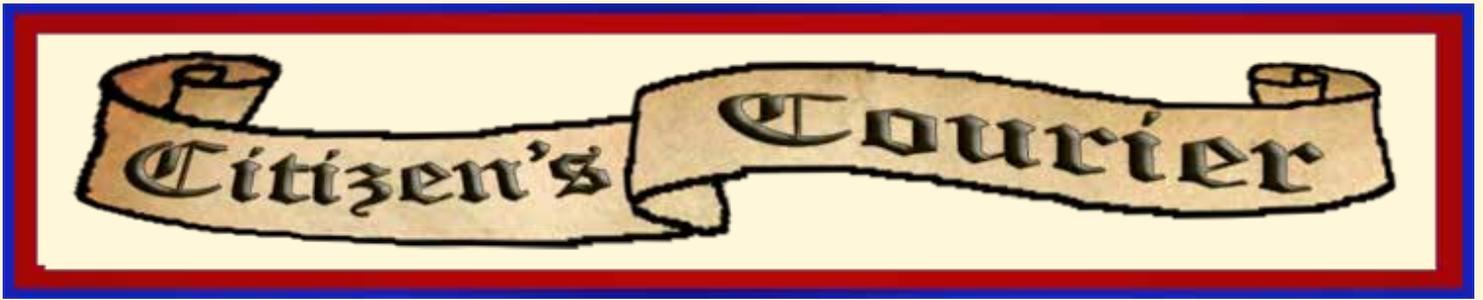
The 2nd Amendment is very clear when it states *"the right to keep and bear arms shall not be infringed"*. Furthermore, Article I Section 4 of the Ohio Constitution states, *"The people have the right to bear arms for their defense and security;"*.

Notice that the Ohio Constitution does not say How we can defend ourselves; Where we can defend ourselves; What we can defend ourselves with; or, Who we can defend ourselves from. The only thing that it does state is 'What' and that is we have the Right to

defend ourselves and provide for our own security.

The ATF is justifying the latest ammunition ban claiming it to be armor piercing and able to be loaded in a handgun and concealed. They are using current legislation created under the auspices of protecting law enforcement officers from harm. They are stating that under the "Law Enforcement Officers Protection Act of 1986" that they have the ability to ban certain ammunition based on the ability for said ammunition to be armor piercing. They state that the LEOPA allows them to identify and ban ammunition based on what the ammunition has as its core material; thus all steel core ammunition can be banned. What they neglect to say is that in some parts of the country, lead core ammunition has been banned because it is poisoning certain types of animals and harming the environment. Because of this lead core ammunition has been banned from use in "Sportsman" activities and steel core ammunition then must be used.





So which is it, do we follow the law and protect the environment and stop using lead core ammunition? Or are we to neglect the environmental impact and continue using steel core ammunition? Perhaps, the answer is to ban all ammunition that is harder than wet paper.

Not only is this yet another unconstitutional infringement of our endowed rights; it is also most likely an act designed to create precedent for future bans on our ammunition choices. Therefore, the Constitution Party of Ohio calls on the Ohio Attorney General and Ohio Governor to condemn this measure and work with the Ohio legislature to draft legislation barring all federal action on unconstitutional measures to restrict our God given rights...

Obama & ATF to Ban AR-15 Ammo



In a move clearly intended by the Obama Administration to suppress the acquisition, ownership and use of AR-15s and other .223 caliber general purpose rifles, the Bureau of Alcohol, Tobacco, Firearms and Explosives unexpectedly announced today that it intends to ban commonplace M855 ball ammunition as *“armor piercing ammunition.”*

The decision continues Obama’s use of his executive authority to impose gun control restrictions and bypass Congress. It isn’t even the third week of February, and the BATFE has already taken three major executive actions on gun control. First, it was a major change to what activities constitute regulated *“manufacturing”* of firearms. Next, BATFE reversed a less than year old position on firing a shouldered *“pistol.”* Now, BATFE has released *“Framework for Determining Whether Certain Projectiles are ‘Primarily Intended for Sporting Purposes’* Within the Meaning of 18 U.S.C. 921(a)(17)(c)”, which would eliminate M855’s exemption to the armor piercing ammunition prohibition and make future exemptions nearly impossible...


