*LETTER OF COMMITMENT TO RUN FOR POLITICAL OFFICE
IN OHIO AS A CONSTITUTION PARTY CANDIDATE*

The Constitution Party of Ohio believes its platform matters and therefore it is imperative that any person seeking elective office as a Constitution Party candidate be in agreement with both the general principles embodied in our platform and particularly the specific positions espoused by the platform. We further believe that the general public should know the positions and values held by any Constitution Party candidate seeking elective office at any level. This Letter of Commitment is a declaration of one's belief in, and commitment to, the Constitution Party of Ohio platform such that anyone can know the candidate's position by reading the platform; any disagreements with the platform will be publically noted as stated below.

I do solemnly affirm that I have read and understand the platforms and Bylaws of both the national Constitution Party and the Constitution Party of Ohio. I further affirm that I am a member in good standing of the Constitution Party of Ohio in accordance with its Bylaws and I agree to abide by such Bylaws. I also assert that I agree with the platform of the Constitution Party of Ohio and the platform of the national Constitution Party where affirmed by, or incorporated into, the Constitution Party of Ohio platform. Any areas of disagreement,

concern, or reservation with respect to the platforms or Bylaws have been noted on a separate page(s), are attached to this Letter of Commitment, and are publically releasable.

I understand and agree that nominations for elective office in Ohio will be conducted in accordance with Article XI of the State Bylaws. As a prospective candidate I agree that I will not publicly announce my candidacy for elective office as a Constitution Party candidate until I have received a letter of authorization from the Ohio Constitution Party State Secretary. Prior to the State Convention noted in Article XI, or subsequent confirmation by the State Committee, I, as a prospective candidate, agree that I will only announce that "I intend to seek the nomination for office as a Constitution Party candidate."

Further, I agree that "the platform matters" and that at all times during my candidacy for public office and at all times during my subsequent election to said office, I will uphold the principles, intent, and specific statements contained in the State Platform (and the National platform as incorporated therein) except as noted in my written exceptions attached to this cover sheet, and subsequently deemed as acceptable by the Convention or the State Committee. If I inadvertently make statements or take actions in opposition to the Platform or Bylaws to which I am subsequently made aware, I agree that I will publically recant my opposition or I will withdraw my candidacy as a Constitution Party candidate or resign my public office as a member of the Constitution Party of Ohio.

Finally, I agree that if at any time the State Committee by a three-fourths vote of the Committee in accordance with the Bylaws, Article XI, Item 6, requests that I withdraw my candidacy or resign my elective office as a member of the Constitution Party of Ohio, I will do so immediately and cease further actions as a representative of the Constitution Party of Ohio.
